## NARRATIVE HISTORY JULY 1945

## SECTION IV

San Remo on the Italian Riviera continued to be the home of the 135th Infantry Regimental Combat Team on 1 July 1945, with the exception of the 2nd Battalion, which was under the control of the 751 Tank Battalion in Milan.

During the period from 1 July 1945 to 4 July 1945, training and I&E Schools went on as scheduled. Road blocks maintained by the lst and 3rd Battalions continued to operate normally, and they filed periodic reports on all movements through their positions,

On 4 July 1945, Independence Day, there was no training scheduled. A regimental ceremony, commemorating the occasion, was conducted in the square at San Remo. In Milan, Lieutenant General Crittenberger reviewed the 2nd Battalion, and a 48 gun salute was fired by 12 tanks of the 751 Tank Battalion.

Units of the 1st Battalion, special units, and Regimental Headquarters moved, by truck, into Carignano, in the vicinity of Torino, on 6 and 7 July 1945. Tents were set up and training continued as scheduled for four days. During this period, the 2nd Battalion assumed command of the city of Milan. The 3rd Battalion moved into positions on the Italo-French border, vacated by the 14th Regiment of the 36th French Division on 9 July 1945. The movement was climaxed at a ceremony marked by the lowering of the French Tri-Color in Ventimiglia, Italy. At this time, command of the border sector passed to the 3rd Battalion.

On 16 July 1945, preparations were made for another move, by train, this time to Udine. The entire regiment reached its destination on the morning of 18 July 1945. During the next few days, tents were erected and cots issued to all the men. The training schedule was started again.

An American Red Cross Enlisted Men's Club opened in Roncis on 27 July 1945 and truck service was initiated in all battalions to transport men to this center. Passes were again made available, on a 15% basis, and a number of men left on a seven day tour through Switzerland. Several men also left to attend a three month's course on the "Artistic, Cultural, Sound and Economic Aspects of Italy" at the University of Florence. The course is conducted by English speaking Italian professors.

On 28 July 1945, "E" and "F" Companies of the 2nd Battalion, left Udine and west to Vicenza to aid AMG to restore law and order, and to control disturbances arising from killings, by civilians, of Italian political prisoners. Raiding parties were sent out several times each day, and almost a hundred suspects were taken into custody.

I&E classes began again on 30 July 1945, with each battalion conducting its own school. Such subjects as Basic Mathamatics, Mechanics, English, Blue-Print Reading, Fundamentals of Advertising, Bookkeeping and Journalism attracted several hundred students throughout the regiment.

The Andrews Sisters and Arthur Treacher appeared in a USO Show at Cividale on 30 July 1945, and a great many men from the regiment enjoyed the performance in spite of a pouring rain.

The remainder of the month passed uneventfully.

# NARRATIVE HISTORY JULY 1945

San Remo on the Italian Riviera continued to be the home of the 135th Infantry Regimental Combat Team on 1 July 1945, with the exception of the 2nd Battalion, which was under the control of the 751 Tank Battalion in Milan.

During the period from 1 July 1945 to 4 July 1945, training and I&E Schools went on as scheduled. Road blocks maintained by the 1st and 3rd Battalions continued to operate normally, and they filed periodic reports on all movements through their positions,

On 4 July 1945, Independence Day, there was no training scheduled. A regimental ceremony, commemorating the occasion, was conducted in the square at San Remo. In Milan, Lieutenant General Crittenberger reviewed the 2nd Battalion, and a 48 gun salute was fired by 12 tanks of the 751 Tank Battalion.

Units of the 1st Battalion, special units, and Regimental Headquarters moved, by truck, into Carignano, in the vicinity of Torino, on 6 and 7 July 1945. Tents were set up and training continued as scheduled for four days. During this period, the 2nd Battalion assumed command of the city of Milan. The 3rd Battalion moved into positions on the Italo-French border, vacated by the 14th Regiment of the 36th French Division on 9 July 1945. The movement was climaxed at a ceremony marked by the lowering of the French Tri-Color in Ventimiglia, Italy. At this time, command of the border sector passed to the 3rd Battalion.

On 16 July 1945, preparations were made for another move, by train, this time to Udine. The entire regiment reached its destination on the morning of 18 July 1945. During the next few days, tents were erected and cots issued to all the men. The training schedule was started again.

An American Red Cross Enlisted Men's Club opened in Roncis on 27 July 1945 and truck service was initiated in all battalions to transport men to this center. Fasses were again made available, on a 15% basis, and a number of men left on a seven day tour through Switzerland. Several men also left to attend a three month's course on the "Artistic, Cultural, Sound and Economic Aspects of Italy" at the University of Florence. The course is conducted by English speaking Italian professors.

On 28 July 1945, "E" and "F" Companies of the 2nd Battalion, left Udine and went to Vicenza to aid AMG to restore law and order, and to control disturbances arising from killings, by civilians, of Italian political prisoners. Raiding parties were sent out several times each day, and almost a hundred suspects were taken into custody.

I&E classes began again on 30 July 1945, with each battalion conducting its own school. Such subjects as Basic Mathamatics, Mechanics, English, Blue-Print Reading, Fundamentals of Advertising, Bookkeeping and Journalism attracted several hundred students throughout the regiment.

The Andrews Sisters and Arthur Treacher appeared in a USO Show at Cividale on 30 July 1945, and a great many men from the regiment enjoyed the performance in spite of a pouring rain.

The remainder of the month passed uneventfully.



## MARRATIVE HISTORY AUGUST 1945

The 1st of August 1945 found the regiment still in the vicinity of Udine, Italy. Two companies ("E" and "F") from the Second Battalion were located in Vicenza, aiding the AUG capture civilians who were suspected of killing Italians political prisoners. The weather during mid-day was fair and warm, but in the evenings it rained and turned chilly. Training continued as scheduled with attack problems, map reading, study of individual weapons, Jap tactics and athletics. The liberal pass policy continued with men going to Switzerland, Venice, Trieste, Grade, and the Brenner Pass.

On 3 August 1945, a USO show, "Three After Three" performed in the Third Battalion area and was very well received. The Commanding General of the British 13th Corps visited the Second Battalion on a tour of inspection.

On 4 August 1945 a regimental awards ceremony was held at the parade grounds. Major General Bolte decorated the eligible men. Company "I" was chosen to be henor guard at the ceremony because of its victory in the regimental drill competition.

After a day of rest, the training schedule was carried out according to plan from 6 to 10 August 1945. Freliminary marksmanship was stressed to the utmost in preparation for firing on the range in the near future. I & E schools continued with classes in English, Mathematics, Small Business, Agriculture, and Radio. Elements of the 75th Highland Heavy Regiment Royal Artillery relieved Company "L" from guard duty at ammunition dumps at Benzone and Gomona. A quartering party loft for Tarcente to prepare for the next move from our present area. Company "I" served as hence guard at the Division CP for the visit of Lt Gen Harding, Commander of the British 13th Corps. A new quota of officers and enlisted men left to attend the Army University Study Center at Florence, Italy.

The rainy season began carly and the Nolina River which ran past the Third Battalion area rose considerably after each downpour. A freak hailstorm on the night of 8 August produced icy pellets 12 inches in diameter.

A competitive gun-drill exhibition was hold at the regimental parado grounds on 11 August 1945 and the men of the First Battalion achieved the highest ecores. The victorious teams were given seven day passes to Venice.

On 12 August 1945, Companies "E" and "F" returned from Vicenza with their mission completed to the satisfaction of SUCLASSIFIED PER EXECUTIVE ORDER 12356, Section 3.3, By Epenell 11'5W MARS, Date 4/17/84

AMG officials. There was a large USD show at the Division CP in Cividale starring Allan Jones, Irene Hervey, and Joan Brooks. A great number of men from the regiment attended and enjoyed the performance.

From 15 to 18 August 1945, the First Battalion fired on the range. The range was named after Pvt Furman L. Smith of Company "L" who was awarded the Congressional Medal of Henor posthumously. A plaque at the entrance to the range reads as follows:

"This range is dedicated to the memory of Pvt Furman L. Smith of Company "L", 135th Infantry, who at Lanuvic, Italy on 31 May 1944 gave his life in a valiant attempt to halt an enemy counter-attack. Armed only with an M-1 rifle, Pvt Smith singlehandedly fought off 80 of the enemy, killing 10 and wounding many more before he himself fell dead. For his indemitable fighting spirit, Pvt Smith was awarded the Congressional Medal of Henor."

On the morning of 15 August 1945, the regiment awakened to hear the thrilling news that Japan had finally surrendered. President Truman announced that the Japanese reply had been received and found acceptable. Hostilitios had ceased! The war was over! But, war or peace, operations still continued. The Third Battalion began to move into Tarconto, some 6 miles from its former area. Three companies, "I", "K", and "L", are all billeted in the workers dormitory of an unused silk mill of the Societa Filatura Cascani di Sota Stabilimento di Bulfons, on the outskirts of town. The factory, once employing 1200 workers, had been closed since February 1944. From May 1944 to June 1945 the CRDA (Cantieri Riuniti Dell Adriatico) aeronautical works of Nonfalcone had been moving equipment to the plant to get it away from Allied bombings at Monfalcone. Now the aviation concern has moved back to its former site. Each company is on a soparate floor, with battalion mess being served in the large hall downstairs.

On 20 August 1945 the First Battalion moved into Trissimo, Italy although "B" and "C" companies remained in the old area for various guard details. All companies of the Second Battalion began to move to their quarters in the vicinity of Tricesimo on 23 August 1945.

From 21 August to 25 August, the Third Battalion fired on Smith Range and the Second Battalion fired their weapons the following week. High score for the regiment was 202 fired by Tec 5 Luther Van Over and Pfc Howard C. Langwell, both of Regimental Headquarters Company.

Sgt Wheeler took it upon himself to neutralize some of the heavy fire they were receiving from four enemy machine gun positions. Working his way through the heavy brush, Sgt Wheeler succeeded in reaching of the positions and destroying it with two hand gronades and his carbine. Two of the enemy were killed iv this action. Sgt Wheeler then crawled some forty yards to another position and silenced it in the same manner, killing two more of the enemy. As a result his platoon was able to move and knock out the two remaining machine guns and take their objective. Sgt Wheeler's courage and devotion to duty reflect highly upon himself and the Armed Forces of the United States. - Home address: Bangor, Maine.

(2) MICHAEL F. MC GINLEY (33620094). Staff Sergeant. Infantry, Corrany "K", 135th Infantry Regiment. For gallantry in action on 20 September 1944, in Italy. When a squad scout was fired upon by enemy machine guns as Sgt McGinley's squad approach ed the crest of a hill, Sgt McGinley opened fire upon one of the positions with hisautomatic rifle, killing two of the enemy and causing the remainder to flee. He then turned his attention to the other position, and exposing himself to the enemy fire. boldly charged the gun. The remainder of the squad, inspired by Sgt EcGinley's action, immediately joined the assault and drove the enemy from the hill capturing two of them as they fled.' With these two positions eliminated, the company was able to move up and take its objective. Sgt McGinley's courage and daring reflect. highly upon himself and the Armed Forces of the United States. Home address: Allentown, Pennsylvania.

(3) ELMER G. FIRESTINE (33830779), Staff Sergeant, Infantry, Company "C", 135th Infantry Regiment. For Sallantry in action on 26 April 1945, in Italy. As Sgt Firestine was approaching an enemy-held town, he noticed an enemy vehicle on the outskirts. Sgt Firestine quickly deployed his squad, and although it necessitated remaining exposed to enemy small arms fire, he directed « rifle grenade fire which knocked out the hostile vehicle and caused the enemy to abandon it. The enemy then took up a defensive position behind an embankment and a fierce fire fight ensued

When the enemy refused his first order to surrender, he continued to advance and subject them to frequent bursts from his automatic weapon. So intense was his fire that thirteen of the enemy surrendered to him. Bgt Firestine's skillful leadership and daring eliminated a threat to his men and reflect highly upon himself and the Armed Forces of the United States. Home address: Reading, Pennsylvania.

### SECTION III

# HARRATIVE HISTORY SEPTEMBER 1945

The first of September 1945, found the 135th Infantry Regiment still located in the vicinity of Tarcento (C-h01366) with the exception of the Second Battalion which was billeted in the vicinity of Tricesimo (C-392299). In addition to conducting the training schedule according to plan, the Second Battalion sent a forty-seven (h7) man detail to work in the pits on Smith Range and all men who had not fired record fire did so.

On Sunday, 2 September 1945, the Regiment rested and the men attended various church services. The third of September 1945 was uneventful as the Regiment enjoyed another holiday. The only exception was the report in the evening of some trouble between Italian Police and Civilians near Lonteprato (C-465388). Capt. Chesebro, Regimental S-3, called the Third Battalion and Lt. Sellers with the aid of four (4) enlisted men went to investigate. The cause of the disturbance was not discovered as the people in the vicinity did not wish to volunteer any information.

On 4 September 1945, uneventful training continued. On 5 September 1945, Training Memorandum  $\frac{1}{n}$ 17, 135th Infantry was distributed throughout the Regiment. It called for a fourteen (14) week training schedule with six (6) hours a day, five and one-half  $(\frac{51}{2})$  days a week. Physical training and close order drill were cut to one-half  $(\frac{1}{2})$  hour a day each, with day ending at 1500 hours instead of 1700 hours. The main purposes of this new training schedule was to attain proficiency in quelling civilian disturbances, to attend A.E.P. classes in preparation for post-war jobs, and to maintain discipline and physical conditioning. This new training schedule became effective 10 September 1945 and also 60 mm mortar firing was started at A.T. Mange near Osoppo (C-269394) by Third Battalion. The USO Show Roxy Revue was shown to members of this Regiment in Gividale at Division Theater. Soldiers were well pleased.

The Third Battalion started firing 81 mm mortar at A.T. Range near Osoppo on 11 September 1945. egistration started for the Regimental I and E School, which was scheduled to start the following week with one hundred and fifty-four (154) men being enrolled from the Regiment. Forty-one (41) men from the Third Battalion left for AUSC, Florence.

The twelfth of September 1945, saw a change in the regimental unit position. One platoon of riflemen from Company "A" moved to San Leonardo (C-637254) and closed in at 1800 hours. They relieved 34th Reconnaissance Troops of their mission. Mission of Company "A" platoon was to maintain order in town and not govern. Simultaneous with this move, Companies "I" and "K", were ordered to move within forty-eight (48) hours to Trieste and Pola to relieve elements of the 133rd Infantry Regiment stationed there. Good news was received to the effect that the 34th Infantry Division will probably leave for USA in late October or early November after screening out the low point men.

A twelve (12) man detail from Company "A" was sent to relieve the 125th Field Artillery of their mission of guarding an anno dump at C-528248. Wellef was effected before 1700 hours. Len will feed from parent organization.

On 14 September 1945, Companies "I" and "K" each with one platoen from Company "L" started their relief of elements of the 133rd Infantry Company "I" commanded by Lt. Holliday, was stationed in Trieste, and Company "K"

commanded by Lt. Bowen set up in Pola, an Italian town, formerly used by the Germans as a port and submarine base. Both companies cleared Tarcento area at 1100 hours.

On 15 September 1945, all men who were armed with bazookas started familiarization firing at bazooka and rifle grenade range in river bed at (C-42303335). An old two man Italian tank obtained from 734th Ordnance Company was used as a target.

After a Sunday of rest, the training schedule was resumed on 17 September 1945, when men of the Regiment saw the V.D. film "Pick Up". Also the Regimental I and E School was set up in a three (3) story building and twelve (12) pre-fabricated huts by Capt. R. E. Leadley, I and E. Officer. Capt. Harry V. Shultis, C6 Company "M" served as school administrator with forty-two (42) enlisted men from Company "M" serving as school cadre.

On 18 September 1945, the remaining men of Companies "I" and "K" moved to Trieste and Pola respectively. They cleared Tarcento area at 0815 hours. The remainder of Company "A" moved to San Leonardo on 19 September 1945.

On Thursday, 20 September 1945, it was announced that men with ASRS of sixty (60) points or more would go home with the Division. Men with Eighty-seven (87) points or over left for USA.

inother announcement on 21 September 1945, was made to the effect that only (Officers with eighty-five (85) points or more and Enlisted i.en with seventy-five (75) points or more) will go home with the Division. However sixty (60) to seventy (70) point men were expected to start home by 1 Hovenber 1945. Leanwhile Training Memorandum #19, dated 21 September 1945 rescinding Training Memorandum #17, dated 5 September 1945, was distributed throughout the Megiment. The following schedule for men with less than seventy (70) points was prescribed. Wen not attending A.E.P. "chools will have one and one-half (12) hours training per day, five and one-half (52) days per week consisting of one-half (2) hour per day of each of the following; calisthenics, close order drill, and orientation.

The 22 September 1945, saw the high point men (70 or over) from Companies "I", "k", and "I" in Trieste and Pola, return to Tarcento in preparation for leaving with the Regiment. Low point men from Company "L" and from Second Battalion replaced them.

23 September 1945, was a day of rest, but preparations were resumed on the 24th for men leaving, when they were processed and checked for equipment. All passes to nearby towns were cancelled but that was more than counterbalanced by the USO Show "Shuffle Along" which was shown to men of this Negiment. The all Negro cast was rated as one of the best that ever toured the LTO.

Special Order #174, dated 25 September 1945, was distributed within the Regiment. It stated that all officers and enlisted men not going home with the Division (officers, under 85 points, culisted men with under 70 points); where to be transferred per this order to the 350th Infantry Negiment, 88th Infantry Division. This order was not to become effective however until

1 October 1945. At the same time Lajor Anderson, Regimental S-4, relieved Lt. Col. Tyler as First Battalion C.O. Major Conrad became Regimental S-4 and Lt. Col. Tyler became begimental Executive Officer when he replaced Lt. Col. Greyer who left the Begiment. The weather had become quite chilly at this time and the first snow fell in the mountains during the night. Hen who would be leaving with the Division were issued overcoats and winter underwear.

Enlisted men with eighty-five (85) points or more left on their first leg of the journey to the USA as casuals on 26 September 1945.

On 27 September 1945, the first elements of the 350th Infantry Regiment, 88th Infantry Division, arrived preparatory to relieving this Regiment. Preparations continued for the move to the Raples Staging Ared with men packing personal equipment and crating organizational equipment to be taken.

On 28 September 1945, General Bolte inspected Company "A" of First Battalion and was well pleased.

A last minute announcement was received on 29 September 1945, stating that the critical score for officers had been lowered from eighty-five (85) to seventy-five (75) points, thereby enabling additional Officers the privilege of roturning to the USA with the Regiment. Trucks arrived in the evening and duffle bags were loaded by units preparatory to the move in the early morning.

On Sunday, 30 September 1945, officers and men who were to leave with the Division arose for an early breakfast (about 0330 hours in most units) and boarded trucks which assembled at the Regimental assembly area at Tricesimo. The convoy, consisting of fifty-two (52) carrier trucks (25ton) and two (2) semi-trailers (10 ton) departed from Tricesimo at 0600 hours under the direction of PES personnel and when last seen were headed in the general direction of the great USA via the Naples Staging Area.
